Galiano Conservancy When you create a gift in your estate plans for the Galiano Conservancy, you are creating a legacy of hope and health for the future.

Protecting, restoring and embracing the natural world that sustains us is at the heart of the Galiano Conservancy's work.

Sharing these values with the community and engaging the next generation in respectful stewardship and sustainable living is paramount to extending our work's impact.



Formed in 1989, The Galiano Conservancy has been a leading force in protecting the lands and waters of Canada's west coast for 26 years. Through acquisition of land and conservation covenants, the Galiano Conservancy has helped to protect more than 2000 acres of land on Galiano Island, located in one of Canada's most imperilled ecosystems.

The first land trust established in British Columbia's southern gulf islands, the Conservancy is widely recognized for innovative approaches to ecological restoration, conservation mapping, habitat protection and action-oriented hands-on environmental education for participants of all ages from the region. The Learning Centre is now the home location of education programming.

By leaving a bequest to the Galiano Conservancy, you can help to secure the peace and beauty of our special island far into the future. Your legacy will help to sustain the work of the Galiano Conservancy for generations to come.



WAYS OF GIVING

BEQUESTS

A charitable bequest is a gift to the Galiano Conservancy made in your will. Bequests can take a number of forms, including a lump sum of money, an asset such as securities or real estate, or a portion of your estate. Bequests are made for various purposes.

Bequests made out to the Galiano Conservancy will generate a tax credit that can create significant income tax savings. At the same time, you will retain full control of the gift and can shape it to your vision of a better future for Galiano Island.

LIFE INSURANCE

While making premium payments, even small current outlays can be leveraged into a significant future gift. Life insurance gifts can be made in two ways; either the policy's ownership is irrevocably transferred to the recipient, or the recipient (e.g. the Galiano Conservancy) is named as registered beneficiary to receive proceeds of the policy, without being the owner.

Insurance policy gifts often appeal to those between 30 and 60 who don't need their older policy, or who want to make a larger gift but have limited resources at the time.

RRSPS AND RRIFS

By naming the Galiano Conservancy as the recipient of your RRSP or RRIF, you will both be making a valuable gift and saving your estate the tax payable on these assets, whether during your lifetime or after. **Western Painted Turtle, T. Harmer**

If donated outside of your estate, you can designate the Galiano Conservancy Association as beneficiary of the RRSP or RRIF. If through your estate, your estate is the beneficiary, and a separate gift to the Galiano Conservancy is made equal in value to the RRSP/RRIF proceeds. Be sure to speak with a financial advisor or lawyer about this option. TYPES OF BEQUESTS AND SUGGESTED WILL CLAUSES

SPECIFIC BEQUEST

When giving a specific bequest, you designate a specific dollar amount or piece of property to the Galiano Conservancy Association. This may be in the form of real estate, stocks, bonds or artwork.

"I give the sum of (bequest amount or description of other property) to the Galiano Conservancy Association to be used for its general purposes as the Galiano Conservancy Association sees fit."

RESIDUAL BEQUEST

When giving a residual bequest, you designate all or a portion of your estate to the Galiano Conservancy Association after your debts, taxes, expenses and other bequests have been paid.

"I give the residue of my estate (or _____ percentage of the residue of my estate) to the Galiano Conservancy Association to be used for its general purposes as the Galiano Conservancy sees fit."

CONTINGENT BEQUEST

When giving a contingent bequest, you are setting up a back up plan. This gift only takes effect if the primary intention cannot be met. For example, if the primary and alternate beneficiaries do not survive the donor.

"If neither (primary beneficiary) nor (alternate beneficiary) survives me for 30 days, then I give (describe amount of cash,

property, percentage of residue or other gift) to Galiano Conservancy Association to be used for general purposes as the Galiano Conservancy Association sees fit."

DESIGNATING YOUR GIFT RESTRICTED AND UNRESTRICTED GIFTS

UNRESTRICTED GIFTS

When you give an unrestricted gift, the Board of Directors of the Galiano Conservancy Association, working with staff of the organization, has the discretion to find the best use of the funds to Galiano that the ensure Conservancy can continue to pursue its mission to "preserve, protect and enhance the human and natural environment" on Galiano Island. Examples on the previous page are for unrestricted gifts.

GIFTS FOR A SPECIAL INTEREST

If you have a special interest, you may decide to restrict the use of your gift to support this area of the Conservancy's work. Changes and developments in the future are difficult to anticipate. That said, we recommend that you include a "power to vary" clause, to ensure that your gift will offer the maximum benefit to Galiano's natural and human environments. The following clause incorporates this, giving strong preference to your particular interest while maintaining some flexibility for unanticipated circumstances. "...to be used for (specific purpose) provided, however, that if the circumstances make the specified use of this bequest gift undesirable or impractical, the Galiano Conservancy Association is authorized to apply the gift to other purposes that confirm as much as possible to the spirit and intent of this bequest."

Bequests can be designated to the Endowment Fund to support Galiano through a perpetual unrestricted gift.

GETTING STARTED

Visiting a lawyer is a good idea when planning your estate. Making sure you have financial security during your lifetime is most important, followed by taking care of your family and charitable giving.

1. COMPILE A LIST OF ASSETS

The first step is to accumulate information about what you own. Your home, assets, special items, business investments such as RRSPs and RRIFs, stocks, bonds, insurance policies and so forth. If you have young children, choose a guardian, and choose an executor/executrix who will manage the process.


2. YOUR VALUES AND DREAMS


If you could do anything with your money, what would you do? How would you help your family or community? Ask yourself what legacy you would like to leave, and what people or organizations hold the most meaning for you.

STOCKS, BONDS, MUTUAL FUNDS

Donating publicly traded securities offer both you and the Galiano Conservancy a huge benefit. They make excellent charitable gifts as they are easy to value and offer significant tax incentives. Gifts of securities can be made now or given in your will. You will receive a tax receipt for the full fair market value immediately. Corporate donors will benefit from a tax deduction and potentially an increased addition to their capital dividend account.

Give securities by having your stock broker transfer (not sell) the securities to our stock broker. Contact us for more information.

PROPERTY

Making a gift of property offer a way to make a substantial contribution while maintaining flexibility and relieving yourself of real estate obligations such as property tax and insurance. You can gift property in several ways including; gifting it outright; leaving it to the Galiano Conservancy in your will; placing it in trust; or retaining the use of it for life. You will receive an immediate donation receipt which will surpass any capital gain on the property.

Real estate may be eligible as Ecologically Sensitive Land, and this changes the process. Speak with us about the possibilities here.

ENDOWMENT

An endowment is an investment fund that creates a perpetual stream of income to the organization. Leaving an endowment in your will or during your lifetime will create a trust where your gift will be invested forever. The principal remains invested, with only the interest being spent.






THE LEGACY CIRCLE




